He was a clinical and business leader of Sentara's hospital, ambulatory, physician and managed care strategies. He practiced internal medicine and rheumatology for over 20 years and was Professor of Clinical Medicine at Eastern Virginia Medical School, where he won three best teacher awards. He is an Alpha Omega Alpha graduate of Johns Hopkins University School of Medicine, where he completed his internship and residency (Johns Hopkins Hospital) and was Assistant Chief of Service and Assistant Professor in the Department of Medicine. He completed fellowships at Massachusetts General Hospital and Harvard Medical School. He is a member of Phi Beta Kappa, and a Fellow of the American College of Physicians and the American College of Rheumatology.

In 2003, Stuart was selected as one of *Modern Physician's* 25 visionary physician 'Movers and Shakers.' He has served on 18 boards of directors in the for-profit and non-profit sectors of the health care industry. He is currently an advisor on the Triple Tree Advisory Council. He was a member of the Institute of Medicine Committee on Enhancing Federal Healthcare Quality Programs, served on two steering committees at the National Quality Forum, was a strategic advisor to The Health Technology Center (Health Tech), and was an inaugural member of the Health Management Academy.
